Subject: Submittal of Information.

Dear General Manager:

Since the compulsory holiday of May 1st, 2013 was transferred to Monday, April 29, 2013 pursuant to the provisions of Executive Decree 233 dated 18 April 2013, we wish to remind you of proviso 1 of Article 1 of General Resolution 5-2012 dated 30 March 2012, which states:

“ARTICLE 1: CONTENTS, FORMAT AND FREQUENCY FOR THE SUBMITTAL OF INFORMATION TO THE SUPERINTENDENCY. The banks shall submit to the Superintendency the information referred to in:

...

PROVISO 1: If a due date falls on a holiday, it is understood that it is extended until the next business day.

In this regard, we wish to inform you that the deadline for the submission of information to the Superintendency of Banks through the ITBANK system is postponed until the next business day according to the frequency of each atom.

Notwithstanding the above, the Superintendency of Banks deems it advisable to provide exceptions for the Weekly Liquidity Atom (AT10) and the Weekly EVAP (Expiration Report). Therefore, we wish to inform you that the deadline for the submission of these Atoms with the data through Friday, April 26, 2013, is extended until 12:00 noon on Tuesday, April 30, 2013, maintaining the closing date on the data to be reported.

We would greatly appreciate your providing your staff with the necessary instructions for compliance with the provisions of this Circular.
